3. You must be 18 years of age or older to purchase a ticket and be eligible to be the winner. The declared winner must have a valid driver's license.
4. Payments may be made either online at www.autismup.org, at the AutismUp facility, or at the Kite Flite event on August 18, 2018. We accept VISA, MasterCard, Discover, and American Express credit cards. Checks or money orders should be made payable to “AutismUp.” If an entrant's check or credit card is dishonored by the bank or declined, the entry certificate will be declared invalid unless and until full payment is made prior to the drawing. If this occurs, we will attempt to contact the entrant by mail or email. Payments are not tax-deductible contributions. All ticket purchases are final and non-refundable.
5. The AutismUp and Vision Automotive/Vision Buick GMC Car Lease Promotion runs from July 26, 2018 to August 18, 2018.

The AutismUp and Vision Automotive/Vision Buick GMC Car Lease Raffle drawing will be held no later than 2:00 pm at the 2018 AutismUp KiteFlite Parade and Festival at Marina Auto Sports Stadium, Rochester, NY on Saturday, August 18, 2018.
